Minutes from the March 02, 2019 Meeting

El Ranchero Restaurant in Vista was the site of the camp's March 2nd Pre-Convention meeting as Camp 302 prepares to join its fellow camps in the California Division as they once again prepare to converge in Bakersfield, California for the annual event. The meeting was called to order shortly after 10:00 AM. Commander Millsap conducted the Invocation. The Pledge of Allegiance and Salute to the Confederate Flag followed. Those in attendance were as follows: Commander Jim Millsap, Lieutenant Commander George Faircloth, Adjutant Jim Stephens, Ira Lack, Wes Scarbrough, Chuck Meadows, John Flood, and guest, Deanne Smith. Deanne brought extra convention registration forms in case anyone decided at the last minute to attend. As always, Deanne was a welcome addition to the meeting's discussions. In the absence of Treasurer Adair, Adjutant Stephens presented the Treasurer's Report.

Old Business: Commander Millsap told those present that Camp Challenge Coins and Ink Pens, as well as Gillis flags, are still available. Adjutant Stephens mentioned the Hunley Envoy Pins that will be distributed to Hunley presenters when available. Attendees were given the results of the January camp elections. All were advised that the revised Article IV of Camp 302's bylaws are in effect.

New Business: The attending camp members went over final details that would affect Camp 302 here in San Diego and that of the division. The attendees were advised of the guest who will speak at the banquet in Bakersfield and all were encouraged to make efforts to attend if they could. Adjutant Stephens told everyone present that the H.L. Hunley JROTC Awards to local high-school students were on track, and he also discussed the California Division meetings that are being held quarterly, particularly the last one at Domingo's Restaurant in Boron, Ca. A unanimous vote was conducted as a quorum of members voted to revise Standing Rules #4 regarding the camp purchase of a Past-Commander medal for the out-going commander. All attendees were reminded of the up-coming Division Convention/Re-Confederation on March 8th thru 10th. The next camp meeting for May 11, 2019 was announced with a proposal to conduct it at the Jolly Roger Restaurant at Oceanside Harbor, this in conjunction with Jefferson Davis' Birthday celebration. The UDC celebration of Confederate Memorial Day was announced to be held at Mt. Hope Cemetery on April 27th.

The next scheduled VMC Color Guard will be on May 25, 2019.

Commander Millsap read the Benediction to close out the second meeting of the year.

At 8:00 AM Saturday morning, division members gathered in the conference room of the hotel to begin the Re-Confederation/ Convention. Division Commander Steve Smith welcomed the attendees and introduced Special Guests: Commander -in-Chief Paul Gramling; ATM Commander Darrell Maples; ATM Councilman J.C. Hanna, and MOS&B Commander Steve Roe. Division Chaplain David Pyle, at *right*, then delivered the Invocation.





He later gave a Scripture reading and report. Color Sergeant Greg Frazier very smartly posted the colors. All in the room stood and recited the Pledge of Allegiance and Salute to the Confederate Flag. A unique beginning to our business session occurred when special guest H.K. led us off with a rousing rendition of Dixie. With the opening ceremonies complete, the guests filed out of the conference room and the business of the convention began.

Division Lieutenant Commander Jon Fowler, at left, read the charge to begin the convention and introduced Division Adjutant Dr. Vern Padgett who

then conducted the Roll Call of the Camps and presented the delegation with the completed minutes of the 2018 Division Convention. For 2019, the following camps of the California Division were present and accounted for: Father A.J. Ryan Camp 302, San Diego - General John Bell Hood Camp 1208, Los Angeles - General George Blake Cosby Camp 1627, Sacramento - Inland Empire Camp 1742, Inland Empire – Captain James Iradell Wadell Camp 1770, Orange County – General Tyree Harris Bell Camp 1804, Fresno – General Albert Sydney Johnston Camp 2048, Bakersfield/Tehachapi – The Stainless Banner Camp 1440, San Jose. Four camps were not present this year: Long Beach, Camp 2007 - Modesto, Camp 2023 - Ventura, Camp 2062 and Santa Barbara, Camp 1631.



At this point, the attending camps presented their reports indicating their past year's activities. Here are a few highlights: Commander Jim Millsap, at left, reported to the delegation of Camp 302's \$1000 donation to the Nathan Bedford Forrest boyhood home and our other activities during the past year. David Pyle of Camp 1440 talked of the camp's Kearny Park Reenactment. Robert Crook of Los Angeles Camp 1208 mentioned the several hundred dollars they raised for H.K.'s trip to California. Tad Smith, Sacramento Camp 1627, laid out their partnership with the UDC for Confederate Memorial Day, the Hunley Awards they presented -13 since 2013, and the fact that

Commander Allen Davis received the UDC's Jefferson Davis Historical Award. Mike Climo, Inland Empire, Camp 1742 made everyone present aware of the 4850 square miles their camp covers (larger than some states), the Hunley awards they presented and the reenactment they attended in Corona. Orange County's Robert Williams reported on their current membership stats and that the Santa Ana Cemetery in their area has 87 Confederates identified and the 8-foot-high 7-ton monument with 10 Confederate founders listed thereon is in ever present danger of being taken down at anytime by the city. Tim Desmond, 1804 Fresno reported their support of Richard Kline and family after their home was destroyed during the Carr fire and thanked all who visited former Division

Commander Chuck Norred at his home. Jon Fowler of Bakersfield/Tehachapi told of how active their camp is, which they are, their monthly meetings and the 49 members they have at present.

It was great to have Commander-in-Chief Paul Gramling Jr., at right, addressing the delegation. Paul has visited the California Division conventions in the past as ATM Commander. He expressed his pleasure, as he always has, in visiting us out here in California.

Division Hunley Award Coordinator Jon Fowler reported to the group that there are still 13 Orphan Schools in the state that need sponsors. Importantly, he reminded all present that after 2021, the military will no longer allow JROTC cadets to wear any lineage awards presented by heritage organizations such as The Sons of Confederate Veterans. They will require military related awards only. Still a few years down the road, it will be interesting to see how this will work.

Kevin Street, referring to social media, told all that Facebook is working better than Twitter when defending and espousing the SCV message. Webmaster Mike Climo indicated that clicking on and bookmarking the SCV California website www.SCVCalifornia.org/ is bound to raise our rankings. Mike told of over 400 attacks on the site but there were no outages with a 99% up-time. Lower South Brigade Commander Robert Williams reported on the four camps under his command: 302; 1208; 170, and 1742. Division Adjutant Dr. Vern Padgett delivered his Adjutant's Report. In it, he stated that the California Division has 12 camps with 275 active members. The largest camp is Sacramento, 1627. The oldest being the John Bell Hood, Los Angeles, 1208 founded in 1951. The newest camp in the division is General Albert Sydney Johnston Camp 2048, Bakersfield/Tehachapi, founded in 2003. Due to the size of California, the camps range in a distance of 504 miles from each other with Father A.J. Ryan Camp 302, the southern most in San Diego to the northern extreme, George Blake Cosby Camp 1627 in Sacramento. Vern reminded all present that the California Division has been meeting annually since 1994, the year the division was founded. In his Treasurer's Report. Dr. Padgett reported that in March 2018, the division had \$2445 in the Division Treasury. After the March meeting of that year, a total income of \$11,238 was received. There was an expenditure of \$9953 at or after that March meeting. Balance Forward, plus income, minus expenses, leaves \$3730 as the current balance. In summary, Dr. Padgett reported that the Division has 9 Gillis Flags and 31



annually.

Division Challenge Coins remaining.

Besides H.K. Edgerton and CIC Gramling, the division was pleased to have Army of Trans-Mississippi Commander Darrell Maples and ATM Councilman J.C. Hanna as guests. *At left*, Councilman Hanna addresses the delegates during the business session. Lieutenant Commander Jon Fowler reported on the support he has received from division officers and he acknowledged the help he has had in coordinating the Hunley awards. Commander Steve Smith then took to the floor and reported that it has been less stressful in recent Re-Confederations as delegation of certain duties assigned to different camps has taken some of the pressure off in the organization process. Commander Smith emphasized his creation to two new division awards taking affect this year: **"The Chuck Norred Leadership Award"** that replaces the Division Rebel of the Year Award, and **"The Dr. Vern Padgett Scholarship Award"** that will award a proposed \$280 to two chosen JROTC schools in California

A few other key business matters discussed during the morning session included the proposal to have a division SCV and SUVCW convention gathering in 2020 with the two groups primarily celebrating at a joint banquet in the evening. More on this to come. Chaplain David Pyle stated that each camp must have a dedicated chaplain, which your camp certainly does in that Jim Colsby and Ernie Powell are our representatives in the California Division Chaplain Corps. Input of camp awards for national consideration was discussed and, as of now, Commander Jim Millsap is pursuing that issue. Camp 302's Roy Adair requested time on the floor to report on his and Robyn's visit to the Nathan Bedford Forrest's Boyhood home while traveling in Tennessee, focusing on the excellent condition this off-the-beaten-path property, owned by the Sons of Confederate Veterans, and the contributions required to maintain this historic site. The division delegates were made more aware of this location after Roy's presentation.

A most important part of this year's Re-Confederation/Convention was the nomination and election of division officers before the end of business. Vern Padgett nominated Mike Climo for Lieutenant Commander and Ryan Williams nominated Robert Williams for the position of Commander. With the elections completed, **Robert Williams is now the California Division Commander and Mike Climo, our Lieutenant Commander.** Other offices filled: Jon Fowler was appointed as Chief-of-Staff; Steven Steinberg was elected as Brigade Commander Lower South ; and David Pyle was reelected as Brigade Commander Upper South.

As the business meeting came to a close, the attendees were reminded of the Memorial Service to be conducted at Union Cemetery the following morning and in particular the service for Past Division Commander Barron Smith. Mrs. Tad (Molly) Smith led in the singing of Dixie and Chaplain Pyle delivered the Benediction. The meeting was then adjourned. After a few hours break, it was time to prepare for the Evening Banquet and for Camp 302 to set up for our assigned duty of conducting the Silent Auction.

As always, it was good to hear from Sandy Padgett as she presented her report and greetings from the Order of the Confederate Rose. Commander-in-Chief Paul Gramling gave the assembled guests an excellent talk on the general state of the SCV and our need on the division and camp level to become and stay active in our Southern heritage defense. The highlight of the evening was the long-awaited appearance of H.K. Edgerton. It was indeed heartwarming to hear first-hand how proud and brave this Southern black man has been throughout his travels and how dedicated he is about his heritage. He talked of the endearing respect and devotion to his mother and the assistance of his companion/brother Terry Lee who accompanied him on this visit. *At left*, H.K. moves briskly back and forth across the

banquet floor delivering Michael R. Bradley's Confederate Flag poem, *I am Their Flag*. His moving presentation of Bradley's work was the show-stopper of the evening.

Then came the time during the evening's festivities to choose the division's Camp-of-the-Year Award given to the camp going above and beyond the norm in a camp's annual performance in a variety of categories ranging from number of meetings of all types, money raised/donated, color guards, events attended, division & national conventions, blogs & letters, ROTC awards, membership and a host of other areas that can make a camp shine. Camp 302, the 2018 winner, entered the re-confederation with enough

accumulated points that placed the camp, we thought, well within the realm of winning again this year. However, Camp 2048 of Bakersfield/Tehachapi garnered the 2019 win with a massive number of points that virtually quadrupled our camp's score due to numerous blogs and letters they sent out. 

THE HUNLEY REPORT:

An Update

Camp 302 is now an annual contributor to "The Friends of the Hunley" project and, as such, we'll publish this update that shows some interesting facts with related photos highlighting the current research, restoration and findings the Hunley Project and the Clemson University Restoration

Institute team are finding during the long research and restoration of this irreplaceable artifact of our Confederate Navy that is coming closer to fruition. The facts you'll read about here are gleaned from the official newsletter of the Friends of the Hunley, *The Blue Light* and, it is here that I wish to thank Kellen Correa of The Blue Light editorial staff for granting *The Conquered Banner* one-time permission to use the drawings and photos you see in this article. I informed Kellen of our appreciation. Copies of *The Blue Light* will be available to members to see at our scheduled meetings.

It has been almost nineteen years since the H.L. Hunley broke the surface of the Atlantic Ocean off Charleston, South Carolina when it was raised in August of 2000. (See: *The Conquered Banner*, Volume 26, Number 4, July 2018.) So much work has been done



since then to bring this Confederate submarine back to near pristine condition. The findings, as the photos will show, are slowly but surely giving the researchers tiny but tantalizing clues that may once and for all determine the fate of the Hunley and her crew as more and more concretion is being removed from this nearly intact vessel. The first clue we'll show here is why the keel blocks, for center-line balance, were still attached to the sub's hull.

The illustration *at left* shows what it should look like if the keel blocks were released as designed.

However, over 1000 lbs. of these counter-weights, some weighing 500 lbs., each were still attached to the hull. The object was to

release them so the sub could surface if the Hunley were to be stuck on the bottom. Researchers do not know why they were not released, but one theory is that the crew may not have been aware they were in trouble. The photo *at right* shows two of the keel blocks after they were de-concreted.



The photos *below* show how the Hunley looked when work started on cleaning the hull and interior portions of the submarine and how they look after extensive de-concretion.



Several artifacts have been recovered as restoration continues. Pictured here *at right* is a brooch and ring belonging to the Hunley's Captain, Lieutenant Dixon. They were found entwined in rotted cloth near his remains.

When restoration of the CSS Hunley is finally complete, future generations will have a chance to view this famous submarine that waited for so long to come to the surface after its crew completed their mission.
