### California Division's 30th Anniversary

Resolute compatriots of the California Division, Dixie West, of the Sons of Confederate Veterans,

motored up and down the state to the central California town of Bakersfield to meet and conduct important business for this year's annual Reconfederation/Reunion, March 8<sup>th</sup> thru 10<sup>th</sup> and to greet the SCV's Commander-in-Chief and the division's guest speaker, Jason Boshers.

The Four Points Sheraton—the division's go-to place for this event—once again hosted the division. It was, however, still in the midst of major remodeling, and this with the discovery that the Bistro Restaurant closed during the work on the hotel, disappointed many of the attendees, as this location served a great breakfast during our past events. Despite this reversal, all had a great time and a productive gathering. Division Commander Mike Climo was assured by the hotel management that the restaurant and everything



associated with the Four Points will be open and ready to go for the 2025 Reconfederation.

Commander Climo and Jim Millsap drove to Bakersfield on Thursday, the 7<sup>th</sup> of March to set up the hospitality room that was generously offered to the division free gratis. Most of the division compatriots began arriving on Friday the 8<sup>th</sup>.

Division Lieutenant Commander & Camp 302 Commander Jim Millsap led the Salute to the Confederate Flag with Steve Madden of the Inland Empire Camp 1442 reading of the Charge.

Adjutant Padgett conducted the Division Roll Call to establish a quorum, which was attained. The camps present: Camp 302 San Diego, Camp 1208 Los Angeles, Camp 1440 San Jose, Camp 1627 Sacramento, Camp 1442 Inland Empire, Camp 1771 Orange County, Camp 1804 Fresno, Camp 2048 Tehachapi, Camp 2061 Ventura. The following camps absent: Camp 1631 Santa Barbara, Camp 2023 Modesto, Camp 2007 Long Beach.

As the business got underway, SCV Commander-in-Chief, Jason Boshers, was introduced to the attendees, most of whom had previously met the CIC in Bakersfield or at National. Commander Boshers later announced that he was amazed to see such a well-organized business meeting. All of us here in the California Division should be aware that this division has always made a great impression with national headquarters.

Here, I will mention some very brief highlights of the reports-*not necessarily in the order they were presented*-by the Division Executive Council members: **Tod Terry, the Division Quartermaster** talked of the division property and storage in Bakersfield, the 1776 known Confederate veterans buried in California and went over briefly the Grave Guardian Program. Tod, as the division's Graves Registration Officer, noted 16 graves are being cared for in California. **Division Chaplain, Sergeant-at-Arms, Color Sergeant Greg Frazier** (*Greg deserves praise for all the jobs he has taken on.*) talked of the event at Old West Days. **Division Adjutant Vern Padgett** in his Treasurer's report mentioned the \$357.00 profit for the division last year, the \$3000.00 contribution to national, the \$600.00 travel fund to both brigade commanders and said that the division now has \$8,226.70 in the bank. Adjutant Padgett then gave the current division membership total as 240 paid members. This would lead **Commander Mike Climo** to talk of low camp membership levels and that all members should attempt to get relatives and friends to join by paying their membership at least for a year if possible.

At this point, Division Historian Russ Person talked of funding for radio spots on the local stations in the Fresno area which are friendly to the SCV. He has been directed to run with this.

During the treasury discussion, it was brought up that it would cost \$530.00 to place an ad in the UDC magazine on the back of the front page for the September issue. This was well received. Motions were made on the floor for a vote which passed unanimously. Division Lieutenant Commander Jim Millsap



presented a brief history of the division and said it was now 30 years old. He also noted that in the beginning in 1994, five camps comprised the division with Los Angeles being among the first.

**Upper South Brigade Commander Tad Smith** talked briefly of his Camp 1627 with 48 members and then presented their check for \$1000.00 to CIC Boshers. **Division Judge Advocate Robert Crook** delivered his report emphasizing the need for camps to provide him with bank info, particularly for tax filing purposes and for emergency situations in which a camp may need financial assistance. Camp 302 members are advised that your camp leadership will be looking into this and everyone will be apprised of the outcome.

It was election time for brigade commanders. Only the Lower South Brigade Commander replacement for Robert Crook would be needed. Jim Stephens, Greg Frazier and Kevin Street were nominated. Greg Frazier, *seen here*, was elected with the majority votes and would assume this position to add to his other chores in the division. Congratulations Greg and thanks for taking on another job in the great work you do for the division.

The camp representatives then gave reports as to their accomplishments for the previous year and up to this reunion. After the data was collected by **Division Chief-of-**

Here are some additional details of the business meeting that can be mentioned: the adjutant presented the minutes of the 2023 reconfederation to the attendees for approval, which was unanimously adopted. Jim Millsap went over the status of the division challenge coins (price for each is still \$10.00). Regarding the H.L. Hunley Awards that have not been issued, Jim Stephens, coordinator for this award, gave Division Adjutant Padgett the remaining four awards belonging to the division as he will be receiving the funds for them in the event a camp request one in the future. Camp 302 also has four remaining rewards on hand. A few Army JROTC schools in the Fresno area have been able to present this award in the recent past.

The 2025 National Reconfederation to be held in Charleston, SC this year was discussed, and Commander Climo advised all camps to submit their national award nominations soon.

A highlight of the business gathering was the Q&A session with CIC Boshers. As to be expected, the financial situation with the Confederate Museum was a key question with all present satisfied with his responses.

To officially close the business for the day, Chaplain Frazier gave the Benediction.

It was time to break for lunch or just rest up for the evening activities. After lunch, many proceeded to the ballroom to start setting it up. Camp 302's Jim Millsap, Jim Stephens, Ira Lack, and George Faircloth

began the task of setting up the tables for the silent auction that would take place at the end of the evening. A large quantity of Civil War related books and periodicals, many donated by Camp 302's Jim Coulsby, plus numerous related artifacts were laid out upon the tables. The Fresno camp set up a section of their own. Several framed art works were made available. A key item donated by Compatriot Coulsby was his black powder pistol that would sell for \$200.00 later in the auction. More on this later.

# Bakersfield - Union Cemetery

The gracious ladies of Bakersfield's Mary Boykin Chesnut Chapter 2634, United Daughters of the Confederacy, provided us with *A Moment* of Remembrance once again at this cemetery's hallowed ground where several Confederate veterans lie at rest. They are among over a thousand Confederate Veterans that settled in California after the war.

Ms. Rhonda Pierce welcomed the attendees and Chaplain Mrs. Ashley Cooper gave the Invocation.

The colors were then posted, and all present recited the Pledge of Allegiance to the United States Flag with Mary Ann Claxton leading in the Salute to the Confederate Flag. Introduction of guests followed with memorials to all Confederate Veterans, Women of the Confederacy and Veterans of All Wars. After the Last roll Call of California



SCV members, came the "Roll Call of States." When the state's name was called out, each person present with an ancestor from that state stepped forward and retrieved a rose that they then placed in the ceremonial vase. Many members there had more than one ancestor to honor. After this, came the presentation of the wreath that honored all.

# Famous Confederate- Belle Boyd

Belle Boyd was born in 1844 in Martinsburg, Virginia (now West Virginia.) Her full name



was Maria Isabela Boyd. When the town was occupied by Union forces in 1861, the 17-year-old Belle charmed and befriended the officers. Posing as an innocent, she carefully noted down unguarded comments about troop movements and plans and smuggled them out by messengers to Confederates in the field. Showing her Confederate heart and mettle, she shot dead a drunken Union soldier who barged into the family home and was attempting to raise the Stars and Stripes over the house. She was tried but acquitted, and the vivacious young Belle continued to be a favorite with the Union officers.

Belle's most famous contribution to the Confederate cause came in May 1862, when she was staying at her father's hotel at Front Royal in Warren County. She discovered that a knothole in her bedroom floor allowed her to eavesdrop on Union officers in the room below. One night she overheard them discussing a plan to blow up key bridges around Front Royal to thwart an imminent attack by Confederates led by General Thomas "Stonewall" Jackson. Belle jumped on a horse and rode 15 miles through Union positions to inform Jackson, who responded by beginning his attack early. Front Royal fell to Jackson and the general wrote to Belle: *I thank you, for* 

myself and the army, for the immense service that you have rendered your country today. He also made her an honorary member of his staff, with the rank of captain.

In 1862 she was arrested but released a month later as part of a prisoner exchange. In 1863 she was imprisoned once again and, this time, released suffering from typhoid. In 1864 she took

refuge in England. When the ship was captured by the Union, Belle charmed a Union naval officer, Sam Hardinge, into helping her. He was court-martialed and discharged, and the two later married in England where she became an actress, making her American debut in 1868. She continued her life as an actress and lecturer on her experiences.

Belle passed away in 1900 of a heart attack and is buried in Spring Grove Cemetery, Wisconsin Dells, Wisconsin. Note the misplacement of the American and Confederate flags decorated on Memorial Day 1953. Confederate Veteran Willis A. Everman of the 3rd Missouri Regiment honored Belle in 1919 by



purchasing a headstone with the following inscription: *Belle Boyd-Confederate Spy-Born in Virginia-Died in Wisconsin- Erected by a Comrade.*

# Camp 302 Meeting

The meeting started at 10:45 and we were pleased to have present the following: Commander Jim Millsap, Lieutenant Commander George Faircloth, Adjutant Jim Stephens, Treasurer Roy Adair, compatriots Gary Faulk, John Brown joining us from Arizona, Mike Climo, Steve Smith, Ira Lack and Jane Zoch of the UDC with husband Robert occasionally looking in.

Commander Millsap gave the opening Invocation, and we all recited the Salute to the Confederate Flag to start things off. A brief discussion on some reenactment events that was happening soon that John Brown was participating in – Hunington Beach was discussed – and John indicated that he would send in some photos and info for future publication in this newsletter.

Mike Climo mentioned that 61 folks were signed up for the reconfederation at this time. Treasurer Adair followed with his Treasurer's report indicating that the camp at present has \$31,160.59 in the bank. Also, the uncashed check that was donated to VUMMF back in October of last year has still not cleared the bank. Treasurer Adair to keep checking this with the possibility of drafting a new one.

We talked about the ailing Jim Coulsby and the fact that his son and daughter-in-law have yet to let us know his situation. Jane Zoch said that she would look into this matter. Adjutant Stephens indicated that he would be calling the WAA headquarters to ask what the donation amount would be to be mentioned on the WAA website.

A few other items discussed that will require additional details in the future are the two camps in the California Division that are below minimum membership requirements and what to do with them; and, Senate Bill 517 that may change the status camps and organizations operating under 501 exemption rules. More on these later.

With no further discussion on pending items, the meeting was brought to a close shortly before 1:00 PM. The camp will gather at Marie Callender's Restaurant on May 11<sup>th</sup> for our next in-person gathering.
